Your Submission

I own a field (Folio No: [REDACTED]) located on Bog Road Kilkee. The field was designated as 'other settlement land' by Clare Coco in 2009 and after that it was designated as 'low density residential'. I have kept this field for my children if they wished to build on it in the future. Our family home was one of the first houses on this road, my mother (Bea Benson) was involved with campaigning for street lighting and sewage to be installed. In the past 10 years several houses have been built on the road, including an estate almost across from my field (approx 44 metres). [REDACTED]

[REDACTED] I now discover that the field is currently designated as 'agricultural' which significantly reduces the value of the land which is estimated at [REDACTED]

In order for my children to either build on the land or sell it I need to have it rezoned back to residential. My parents kept this land since the 50's for us to have for our future and it is a great disappointment to me that it has been designated agricultural, especially when there are not too many sites available this close to the town centre - my field is approx 370 metres from the church. As it stands the field is worthless to my family, we can neither build on it or sell it. Please take into consideration that it is the last field inside the town boundary where it lies, and could make a lovely home for someone in the future. I ask you to rezone my field back to residential so that it can be of some benefit to the community in the future. I await your decision with hope. 



The submission sought the relocation of the infrastructure safeguard for the ring road which runs through the site and requested rezoning of lands as Residential.


The decision was made to realign the infrastructural safeguard and to rezone remaining lands as Other Settlement Land.
