On behalf of Summercove Owners' Management Company CLG, C/O M&C Property, 9 Lower Cecil Street, Limerick, The management company wish to lodge a submission for the application for the change in zoning in the area located in red on the attached map. The area is located at the top of Summercove Estate, Station Road, Lahinch, Co Clare.

The reason the management company wish to lodge a submission is due to the following:

Inadequate Space: there is inadequate space for any potential housing in the area marked in Red on the OSI map, the access from this area on to the road would unsafe.

Green Area: The green area separating Summercove from the road would be a massive loss to all the residents in the estate and nearby houses. Should the area be rezoned for residential development a large number of house in Summercove would be over looked by any proposed development and would create a privacy issue for those residents.

Sewage System: The sewage system in Lahinch is already under pressure and the management company would query if the facility would be able to sustain any further pressure by adding further houses to the system, especially under the summer season when the area is fully occupied.

Drainage: It has been noted that the drainage in the area is in poor condition.

Traffic Flow: In the peak of the summer, you will note that motorists encounter a number of problems due to the heavy flow of traffic and cars being parked in undesignated areas. This causes a number of issue for the residents in Summercove , especially with no footpath in situ for residents to walk on.
